### Present Status of Retinitis Pigmentosa (RP) THE FAMILY AFFLICTION 1995

As stated before, Retinitis Pigmentosa is an inherited disease in which the retina degenerates in many places over time. In 1985 it affected about 1,000,000 people in U.S.A., about 23,000 were legally blind due to Retinitis Pigmentosa. The patient first notices poor night vision, then loses peripheral vision, although central vision may be as good as 20/20 until middle age. There is no known treatment and eventually tunnel vision (down to a small pin hole, then total blindness) results. There is no known cure, even today.

As we now know, all of John Jackson and Alice Burton Titchenal's children except Myrtle had Retinitis Pigmentosa (RP). In order to try to analysis the future path of this family disease. I have summarized the path of RP in our family in the following charts. The names of each Descendant that have (or have had) the disease are printed in bold and underlined , all others have not had (or have) the disease.

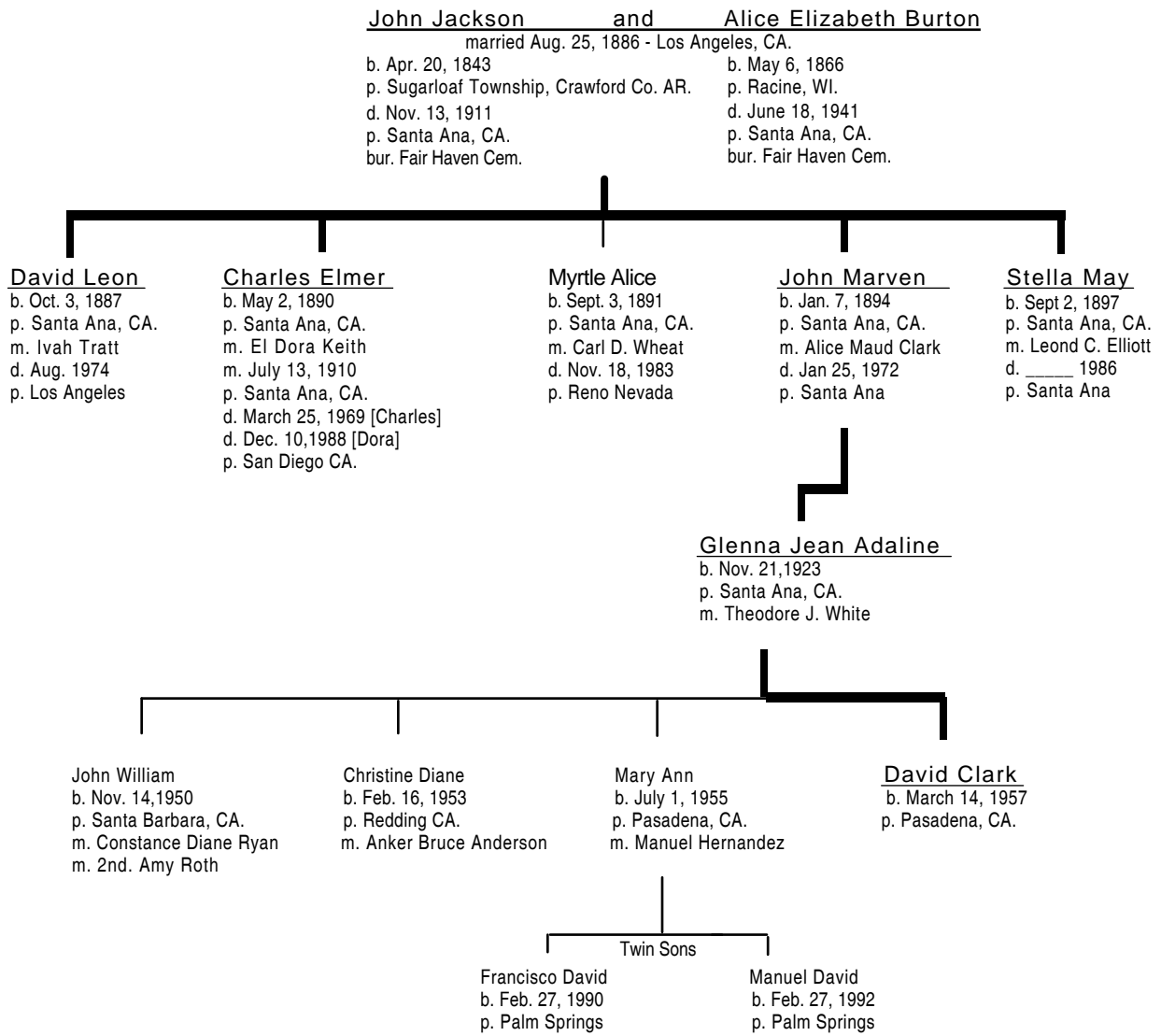
One type of RP is transmitted mostly, by the female to the male. This seems to have been true in our family, so far the disease has not been transmitted to a son through a son, only through daughters. If this holds true, it would seem from the path of the disease to date, that RP may have run it's course in our family.

However, Charles Elmer's daughter, Alice Heine, did not have RP, but her son Charles did. Under this circumstance, the only children in line of decent by daughters from Alice (Burton) Titchenal Have gotten it. However some children could still be in doubt, for example; Edwin Leond's daughter Leanna Lyne's two sons, Christopher and Ashley. Likewise, Glenna Jean's daughter, Mary Ann does not have RP, but her two sons, born in 1990 and 1992 could be suspect and should be checked regularly.

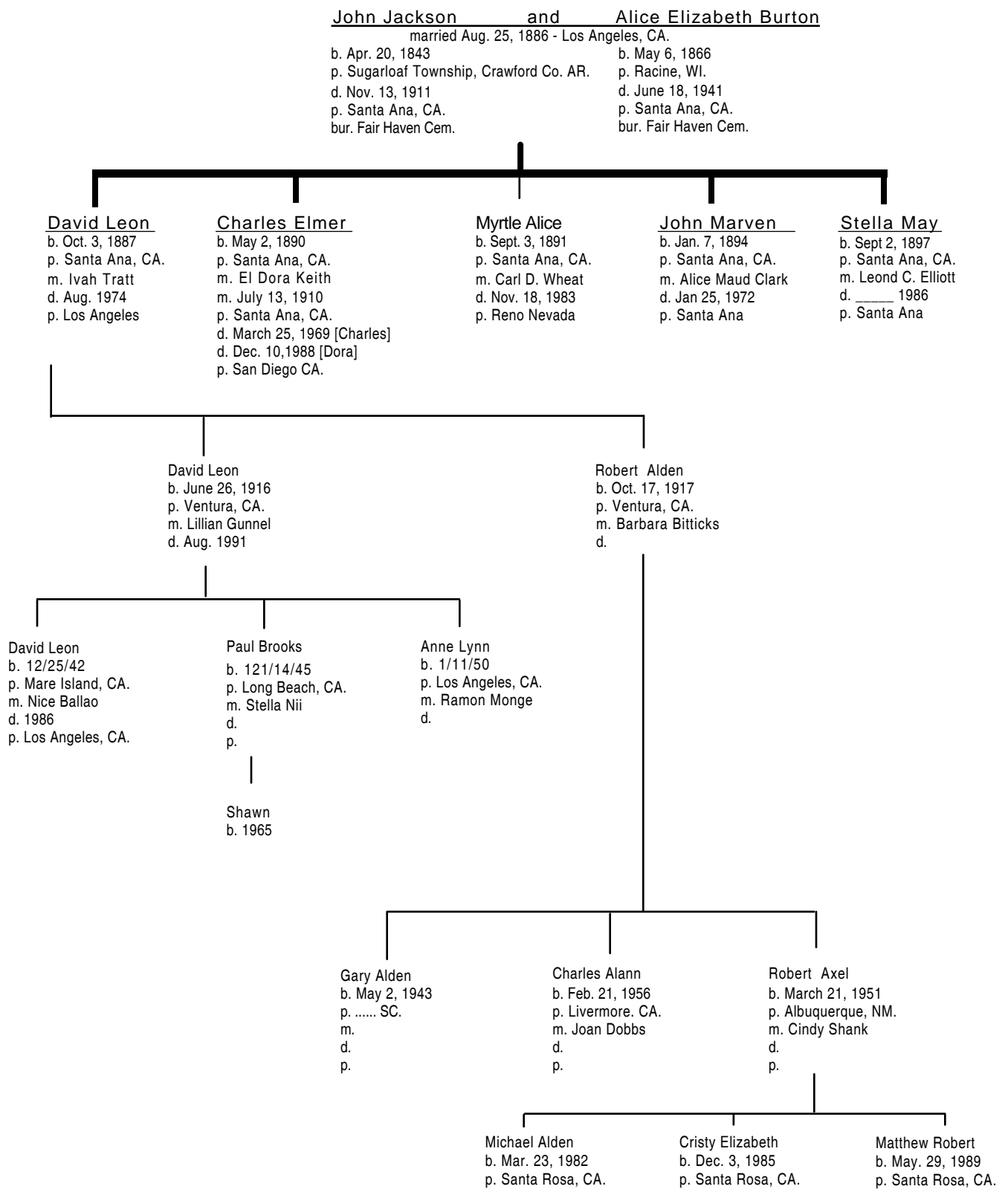
Alice's son, Jack Heine, did not have RP nor did his daughters, Alison and Michelle, (Jack was not Becky Sue's father), Their children are not likely to have RP; but to be on the safe side, Eric, Robyn, Amy Marie, Evan Mark and Jared Matthew should be checked regularly.

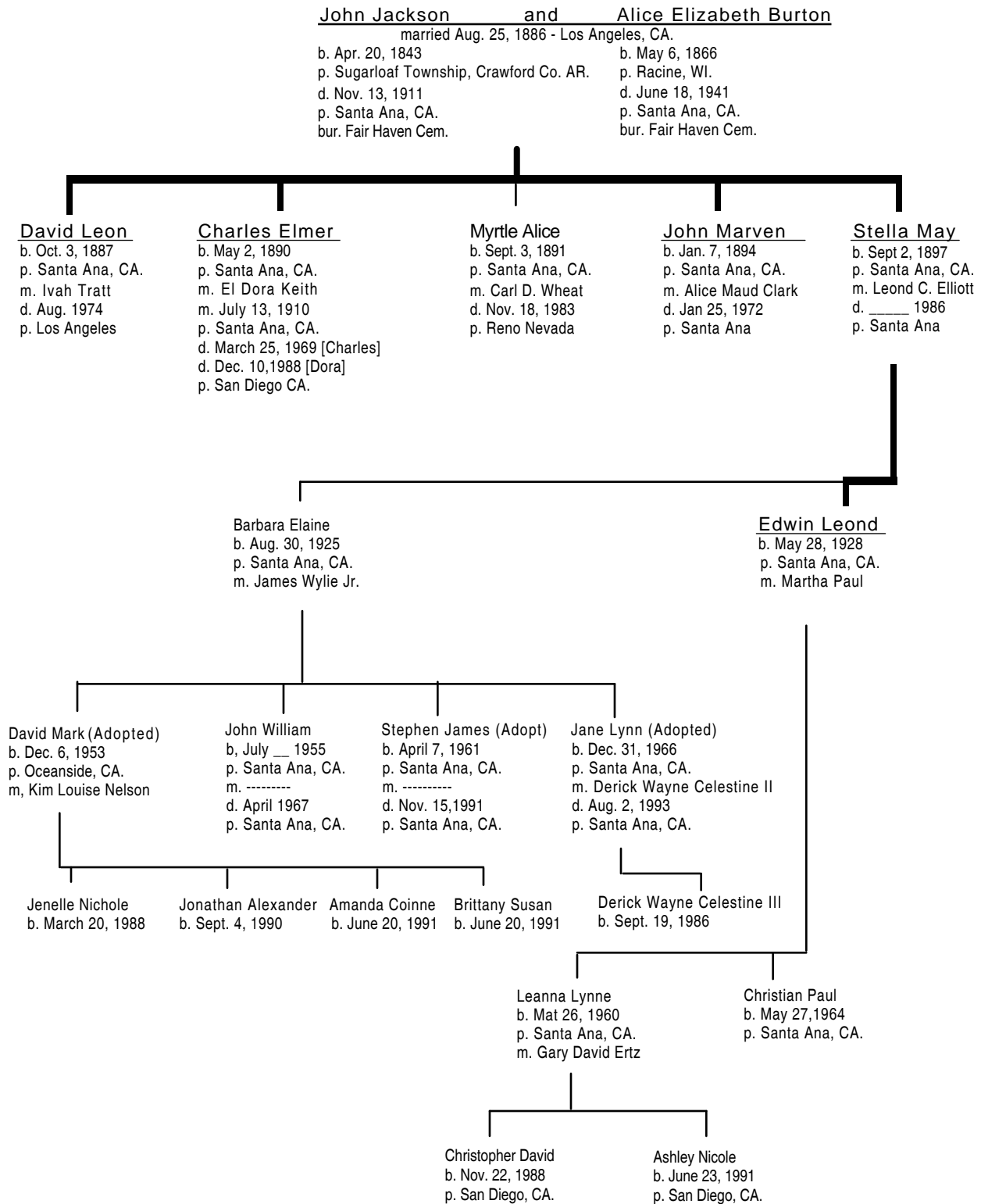
Retinitis Pigmentosa (RP) Chart

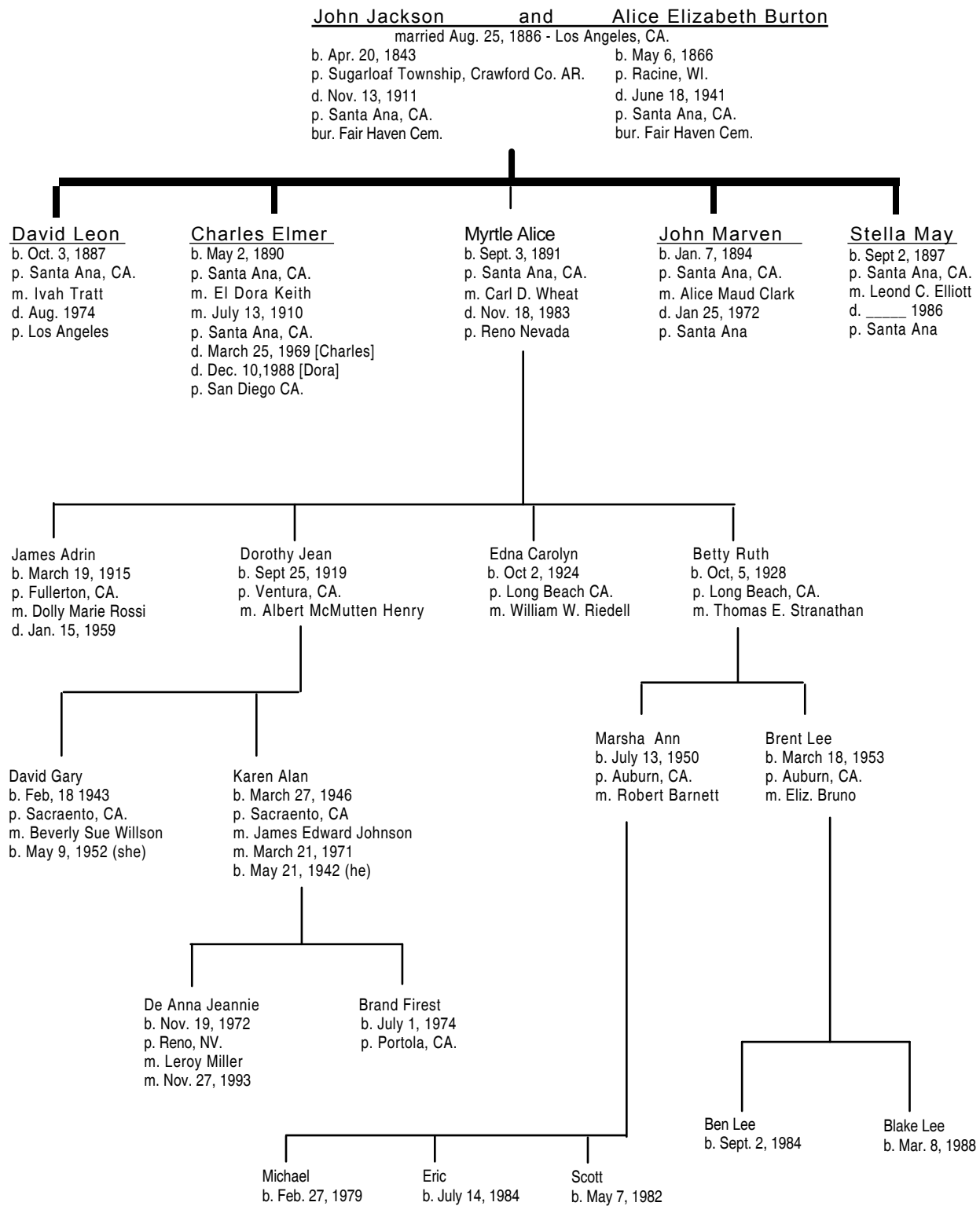

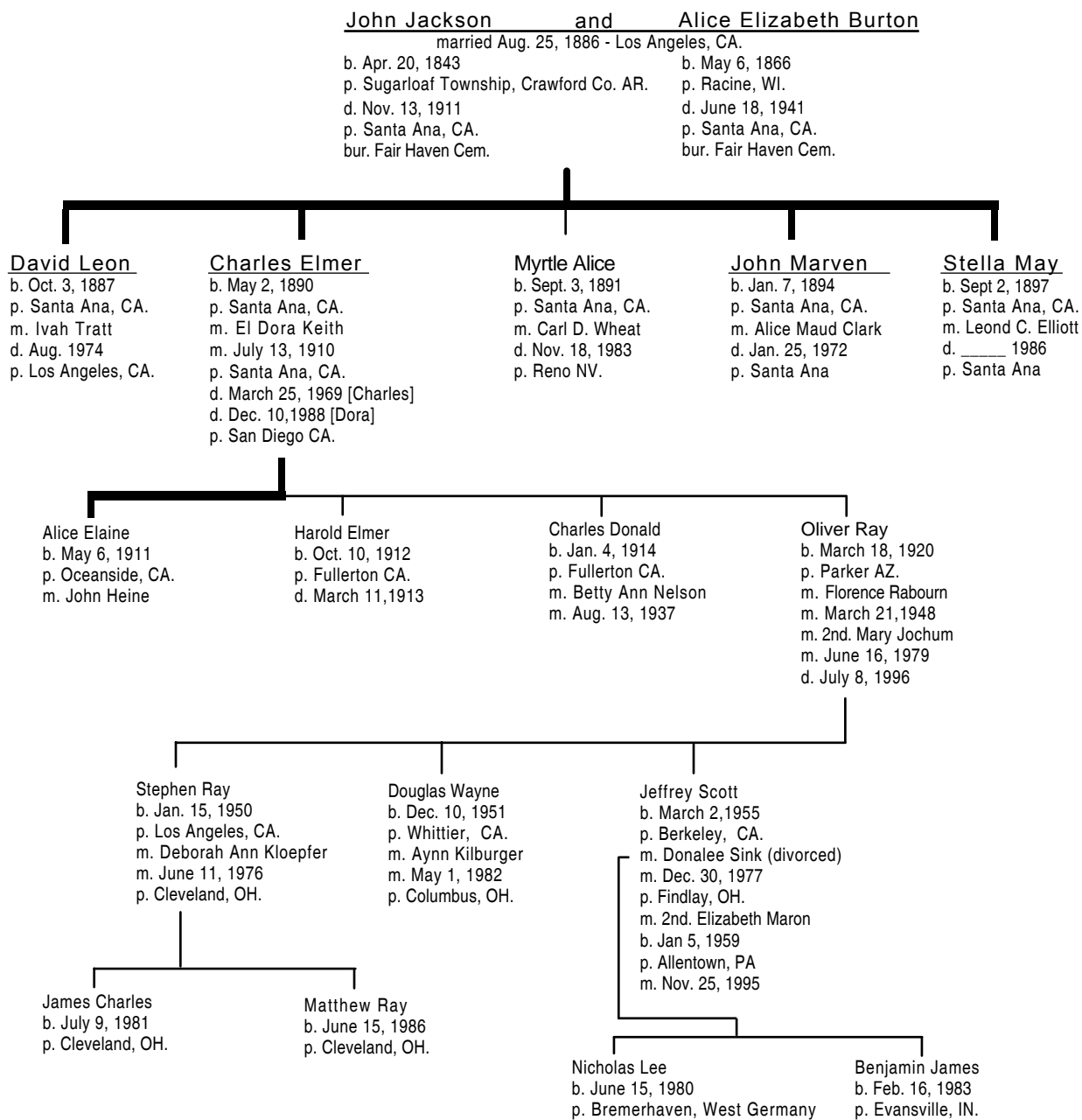

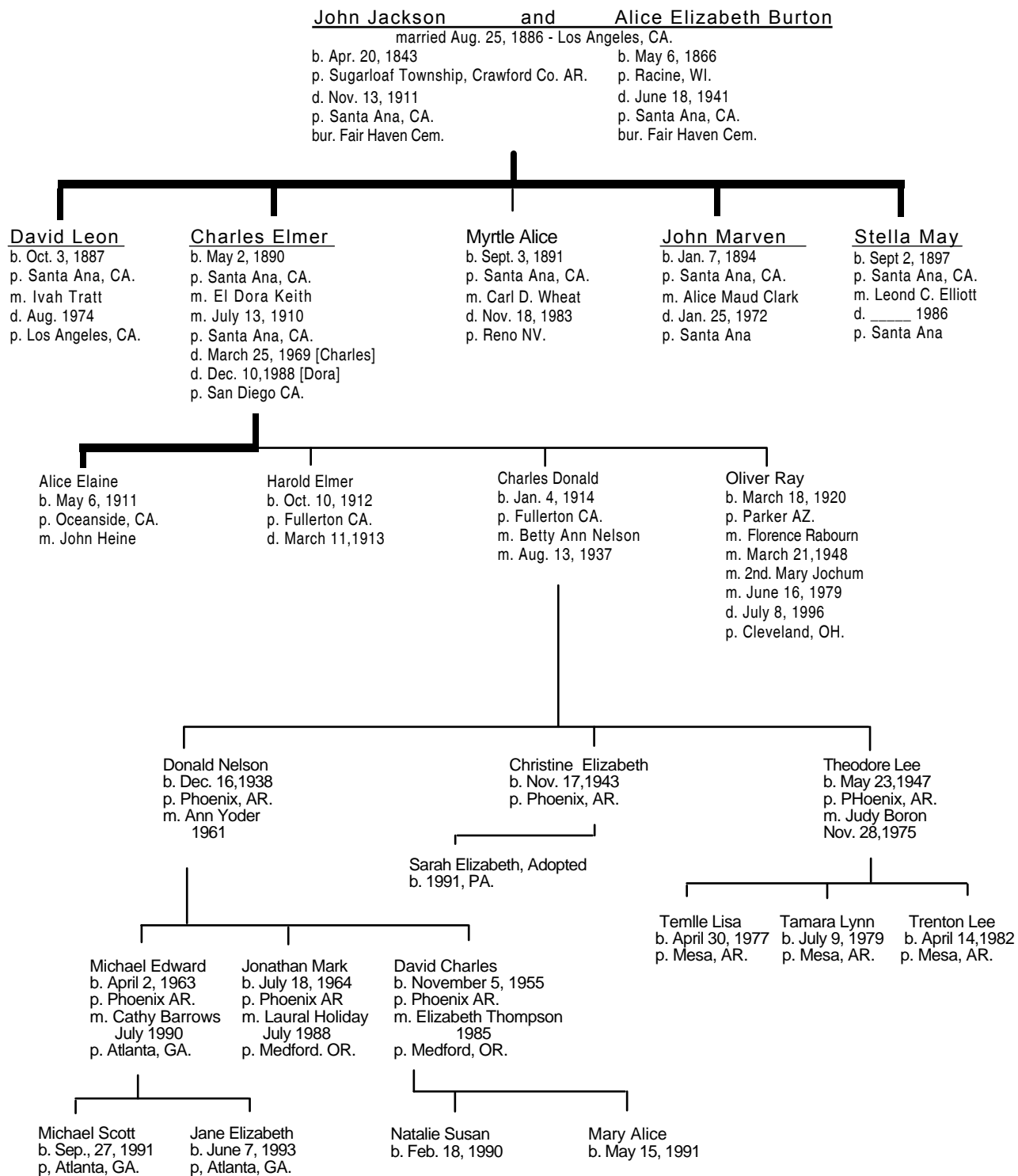
